

VBA Bank Day Scholarship Program FACT SHEET

The third Tuesday in March was declared Bank Day by the Virginia General Assembly in 1991. On this day, high school seniors spend a day in banks across the Commonwealth shadowing a banker in their daily duties. The purpose of





Seven scholarships (six regional and one statewide) will be awarded on the basis of the essays. There will also be six honorable mention scholarships (one in each of the six regions).

Bank Day will take place on Tuesday, March 20th, and the VBA Emerging Bank Leaders are encouraged to participate in, lead and help promote the program.

On this day, you will spend a day in a bank shadowing a banker in their daily duties. After the Day, you will write an essay based on your experience. These essays will be judged by bankers and thirteen scholarships (twelve regional and one statewide) will be awarded to the winners.

VBA Bank Day Scholarship Program ESSAY GUIDELINES

Essay Topic: "What did you learn on Bank Day that will help you manage your financial future AND what did you learn about how banks support their communities?" Using what you learned during your Bank Day visit, please write an essay on this topic. Please follow these guidelines as you write your essay.

- Essay must be typed in English within <u>ONE</u> Microsoft Word document (Google docs will not be accepted).
- Essays must not deviate from the assigned topic. Essay MUST address both parts of the essay topic.
- Essay must be typed in 12-point Times New Roman font.
- Page set-up must include 1.5 lines spacing with all margins set to 1 inch.
- Include a title page (separate page <u>within</u> the Word document containing your essay, not a separate document) with the following information:

 - o E-mail address
 - o Phone number
 - o School's name
 - o Name of bank where you shadowed o Name of banker you shadowed

 - o Date submitted
 - o Title of essay
- Do not include your name or any personal information on any page other than the title page.
- Essay is limited to two pages (not including the title page or works cited page). Writing beyond this limit will result in disqualification.
- Those who plagiarize will be **disqualified**. All ideas must be your own. Any references must be cited.
- Essays must be submitted via e-mail to the Virginia Bankers Association at bankday@vabankers.org by 5 p.m. on Friday, April 11th.
- Late submissions and submissions not written according to guidelines will not be accepted.

VBA Bank Day Scholarship Program SELECTION CRITERIA

Sponsored by the VBA Education Foundation and the VBA Emerging Bank Leaders

Essay Topic: "What did you learn on Bank Day that will help you manage your financial future AND what did you learn about how banks support their communities?"



Student essays are assessed by members of the VBA Emerging Bank Leaders (EBL), the group of more than 470 bankers that connects Virginia's emerging bank leaders to engage them in the future of the banking industry. The essays are sorted into six regions based on the students' home addresses and are reviewed by bankers who do not reside in that region (student names are removed from the essays prior to the scoring process). Those bankers select the top two to be named the regional and honorable mention winners. The regional winners' essays are then sent to the statewide winner selection panel which consists of banking executives from across the Commonwealth.

Northern Virginia Region

Valley Region

Central/ Southside Region Capitol Region

Hampton Roads/ Eastern Shore Region

Essays are scored using the following rubric:

- Content: 40 Points
 - Adherence to essay topic
 - Logical interpretation of the topic; easy to follow

Southwest

Virginia Region

- Creativity: 40 Points
 - Interesting and thoughtful presentation of the topic
- Accuracy: 20 Points
 - Grammatically correct
 - Proper format, adherence to essay guidelines [please see essay guidelines sheet for more information on how to structure the essay]
